# **Disclaimer**

Under the terms of your NOI or Reclamation Permit and Colorado Statutes, you must submit Annual Fees and Annual Reports (including a map). The Fee and Report are for LAST YEAR'S mining and reclamation season, and MUST be paid even if your operation was inactive.
