Dear Party and/or Interested Person:

The Division of Reclamation, Mining and Safety (Division) has received written objections to the PR-15 application, submitted to the Division on March 29, 2018, by Mountain Coal Company, LLC. Therefore, pursuant to Rule 2.07.4(3), the Division has scheduled the application for a Formal Hearing before the Colorado Mined Land Reclamation Board for consideration.

The hearing has been scheduled for the October 24, 2018 Board meeting, which will occur at 1313 Sherman Street, Room 318, Denver, Colorado, beginning at 9:00 a.m. or as soon thereafter as the matter can be considered. During the hearing the Board will consider the application with objections and may decide to approve, approve with conditions, or deny the application for PR-15.

Consistent with the process set forth in 24-4-105(4), the Division has scheduled a Pre-hearing Conference to occur on Wednesday October 10, at 2pm. The Pre-hearing Conference will be held to discuss Board hearing process, identify issues for hearing, determine party presentation order and allocate time, and identify witnesses and exhibits.
