Dear Mr. Ebert:

The following discussion and attachments are submitted on behalf of our client, North Weld County Water District, in response to the Adequacy Review comments prepared by the Division of Reclamation, Mining and Safety (the Division) dated October 16, 2018 for the Lamb Lakes site Regular (112) Operation Reclamation Permit application. The information and discussion below address each comment as it was presented by the Division.

Rule 6.4.7 – Exhibit G – Water Information

- 5. Prior to new mining and reclamation activities on the Lamb Lakes Site, the applicant commits to providing the Division with a Technical Revision that includes the site Groundwater Monitoring Plan. The Groundwater Monitoring Plan shall include an agreement with the Fort Collins Irrigation Canal Ditch owner addressing potential irrigation flow impacts OR procedures to detect, measure, and mitigate losses to ditch flows during mining and reclamation activities. The applicant understands that the Technical Revision will need to be approved by the Division prior to commencement of new mining and reclamation activities.
- 7. The Groundwater Monitoring Plan shall also include recommendations from the Hydrogeologic Evaluation (Blue Earth Solutions, LLC, October 2018) and at a minimum:
 - a. A map that accurately shows the location of all monitoring wells/piezometers in the plan,
 - b. Well/piezometer construction and completion information that demonstrates measurements from the well/piezomenter are representative of actual groundwater conditions,
 - c. Sampling procedures and frequencies routine quarterly measurements shall be required and monthly measurements shall be required during lake/pit dewatering,

- d. Reporting requirements at a minimum, groundwater monitoring results shall be provided to the Division with the Lamb Lakes site annual report,
- e. Potential groundwater impact mitigation measures and groundwater elevation "trigger" levels for each well/piezometer that will require notifying the Division and possible mitigation implementation,
- f. Baseline groundwater elevations that include at least 18 months of monitoring prior to any new site mining or reclamation activities,
- g. Private wells west of the Cache la Poudre River and within 650 feet of the proposed permit boundary. If permission can be retained from the private well owner, the private well shall be included in the monitoring plan with the same monitoring frequency as the on-site wells/piezometers. Routine quarterly measurements shall be required at the private wells and monthly measurements shall be required during pit dewatering. The private wells will be accurately located on the monitoring plan map and, if available, well construction information shall be obtained, evaluated and included in the monitoring plan. Every attempt shall be made to collect 18 months of baseline elevation measurements prior to new mining and reclamation activities.

Rule 6.4.19 – Exhibit S – Permanent Man-made Structures

13. Prior to new mining activities and construction of the slurry wall on the Lamb Lakes Site, the applicant commits to providing the Division with a Technical Revision that includes stability analyses for existing and proposed slopes during pit bottom mining, existing slope reconstruction, and slurry wall construction. The applicant understands that the Technical Revision will need to be approved by the Division prior to commencement of the listed mining and reclamation activities.
