**IN RE:** NOI to collect samples outside of the current permit area on our current claims in preparation for filing an amendment to increase the number of permitted acres.

PERMIT NO.: **M-2011-029**

**Dear Jennifer:**

On behalf of Jubilee Venture, Inc. an FHMC company and the operator of the Eagle Mine in Moffat County, Colorado, permit number noted herein above, hereby file this NOI.

This NOI is filed for the purpose noted above and will comply with all Federal, State, and BLM regulations. The temporary sampling project planned is detail below for your review as required for compliance regarding such notices and purposes.

<b>PURPOSE:</b>	Collect samples from 18 of 19 sample test holes outside of permitted area.
<b>DATES:</b>	START ON Monday, Oct 15, 2018; END ON Wednesday, Oct 17, 2018.
<b>EQUIPMENT:</b>	Rubber Tire Backhoe or Track Hoe Excavator - other vehicles: water truck.
<b>SITE MAP:</b>	Map of disturbed locations of all 19 test holes within claim area attached.
<b>SAMPLE WEIGHT:</b>	Approx. weight of sample per hole collected will up to 1.5 ST/3K lbs.
<b>DEPTH OF HOLES:</b>	Approx. depth of each test hole is 10 feet.

**PROJECT & RECLAMATION PLAN:**

1. The temporary sample collection project required in determining the expansion of the current permitted area projected for 2019 will cause a very minor disturbance with a single piece of equipment that meets regulations for air-quality standards. Test holes will be dug with material loaded into 1.5-ton super bags that will be taken to trucks waiting on current access road for unloading.

2. All 19 holes will be immediately filled in to be reclaimed with contouring landscape and topsoil immediately replaced, with reseeding where needed with only approved seeds recommend by BLM and further stated in current mining permit. No other disturbance will occur outside of the current 14 acres permitted and within the boundaries of our current mineral claims.
3. Dust control will be maintained by water truck as needed.
4. Pictures will be taken of all disturbed areas before and after and will be filed at the Corporate Office and the Mine Site Office and available for inspection upon request. FHMC/JVI will gladly provide pictures by email or delivered to local BLM office if requested, evidencing all reclamation work was performed in a proper manner and as represented in this NOI.
5. The time required to accomplish this sampling project and complete reclamation is three (3) days as stated herein above.

This NOI has been written and submitted as required this 12<sup>th</sup> day of October 2018. No details have been left out or misrepresented and are factual. Should any aspect of this NOI require modification, your office will be notified immediately with an amended NOI stating any required modifications, if any. None are expected or anticipated as of this date.

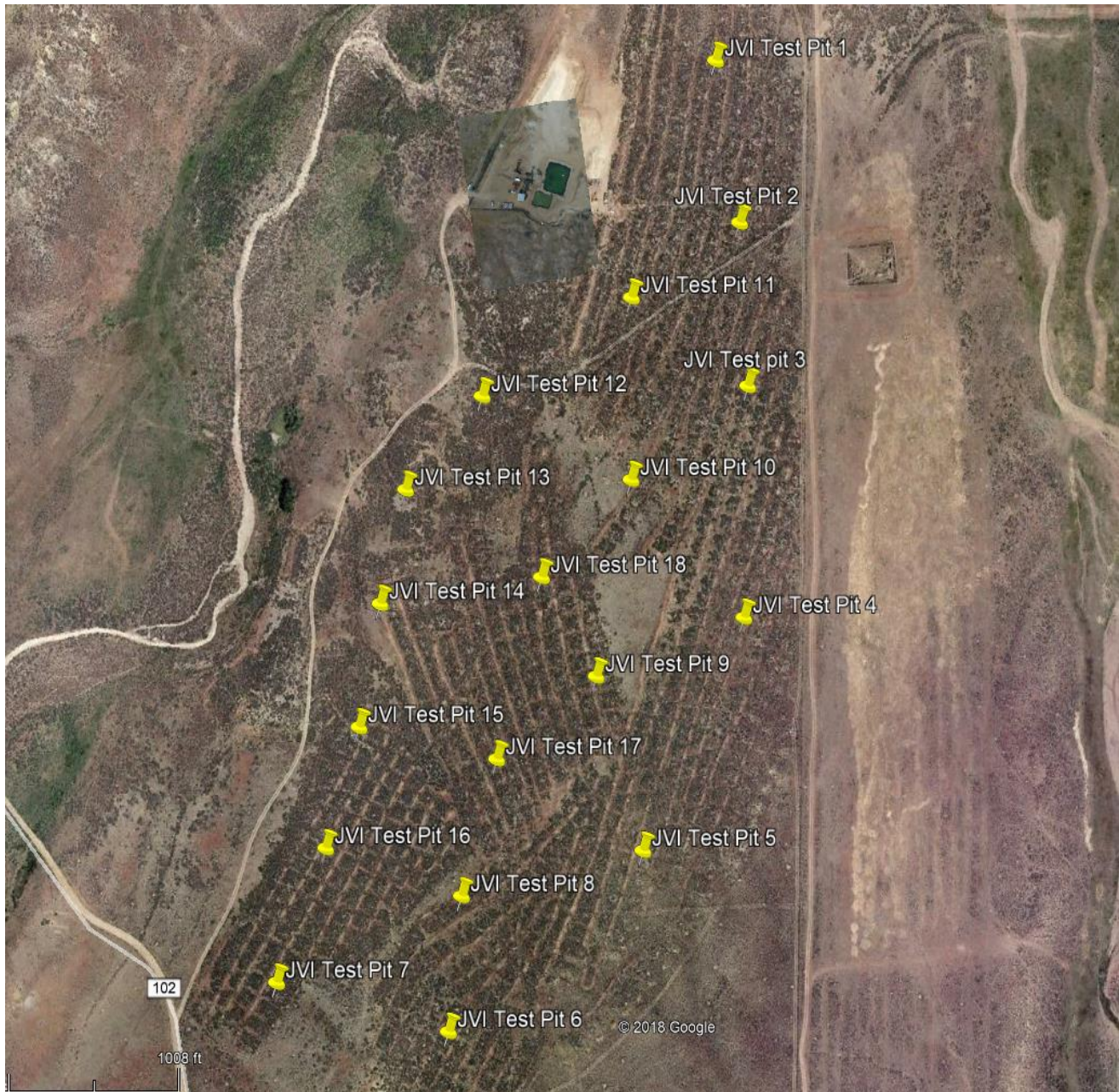
