Exhibit G includes a signed and notarized statement that Eagle Reclamation, LLC. is the owner of the land and the applicant. This letter no longer appears to be accurate and/or valid. Please submit the applicant's source of legal right to enter and conduct operations in accordance with the above referenced rule.
