The modification application for the Dawson Gold Project Notice of Intent (NOI) was submitted by Zephyr Gold USA Ltd. (Zephyr Gold) to the Division of Reclamation, Mining and Safety (DRMS) on November 27, 2018 and considered complete for the purpose of filing on December 6, 2018.

The Division's review period for the application will close on January 7, 2019, unless an extension is requested by Zephyr Gold.

The Division posted the non-confidential form (Form 2) on the Office website on November 28, 2018 in accordance with the requirements of Rule 5.1.3. Any public comment or request for disclosure of information designated as confidential regarding the NOI must be received by the Office no later than ten (10) working days after the notice was posted on the Office website (December 12, 2018). This letter acknowledges receipt by the DRMS of your timely comment.

The DRMS has no objection process for NOI applications. However, as we received a timely comment from you, you have an opportunity to appeal a decision made by the DRMS if we receive a Notice of Appeal within five business days of our decision (pursuant to Rule 5.1.3(d)(II)). Also, as you submitted a timely comment, you will be notified of our decision (pursuant to Rule 5.1.3(d)(I)) via email.
