On July 8, 2017, an elevation survey of Points 1 through 20 was performed. The attached table below show the results of that survey.

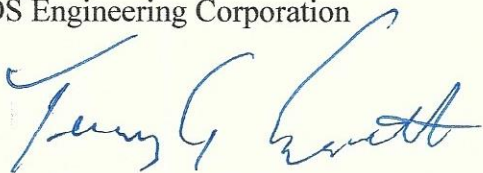
