CONSENT TO PERMITTING ACTIVITIES

This consent is granted by the City of Aurora, whose address is 15151 E Alameda Parkway, Suite 3200, Aurora, Colorado 80012, in favor of Aggregate Industries-WCR, Inc. ("AI"), whose address is 1687 Cole Boulevard, Suite 300 Golden, Colorado 80401.

Aurora and AI are parties to a purchase agreement pertaining to gravel pit reservoirs near Brighton, Colorado, and are in the process of amending said agreement. The parties contemplate that certain lands now owned by Aurora, and described in Exhibit A hereto (the "Real Property") will be mined by AI pursuant to the amended agreement.

Aurora hereby consents to AI's inclusion of the Real Property in all state and local permit applications necessary for AI to conduct a sand and gravel mining operation on the Real Property. This consent will automatically terminate in the event that AI and Aurora have not entered into an Amended Agreement providing for AI's mining of the Real Property by September 30, 2019.

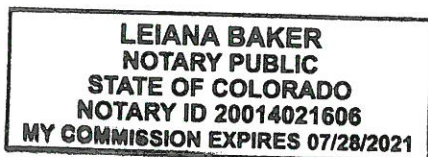

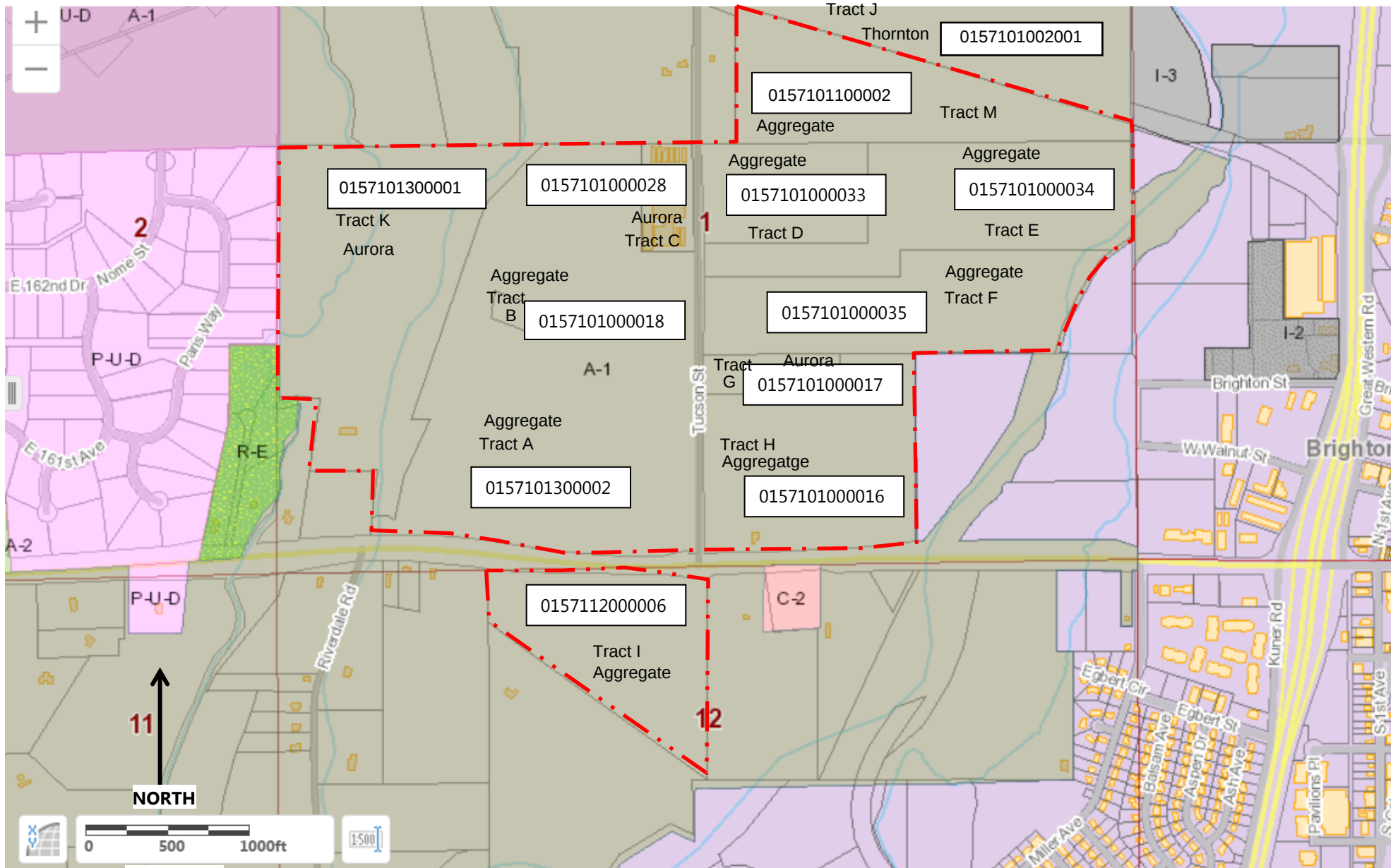
