Box 628, Nuclea, CO 81424 has filed with the Division of Reclamation, Mining and Safety an application for Technical Revision No. 87 (TR-87) to the New Horizon Mine Permit No. C-1981-008. TR-87 proposes construction of an erosion protection inlet into Pond 013 to accommodate trench drain discharge into the pond.
