Dear Mr. Morrissey,

Please find enclosed a completed *Notice of Intent to Operate a Mining Claim*. I have also enclosed a copy of a portion of a map showing the approximate location of my claim, with labelled areas we intend to work and an area which appears from satellite imagery to be suitable to park a vehicle. To summarize my intentions: I intend to dredge Willow Creek with a motorized dredge which will be hand carried to the creek, has a six inch intake. The manufacturer has stated that the practical production rate for this dredge is approximately seven cubic yards per hour. There will be two people actively working on the claim, and we intend to operate the dredge for about two weeks. Based on these revised figures, we estimate the total disturbance to be approximately 350 cubic yards.

Travel to and from the claim will be via car or truck to the extent that existing roads permit. Access to the general claim area will be made via Forest Service Road 123 and County Highway 456. No new roads will be constructed on the claim site. Where motorized vehicles are not permitted, travel will be on foot with equipment being moved by hand/hand cart.
