I just wanted to let you know that Daylan Figgs is the current Permittee/Operator, Permitting, and Inspection contact for East Rigden and Port of Entry.

For Resource Recovery Farm, Daylan Figgs is the Permittee/Operator contact, and Mark Sears is listed as the other two contacts.

For Shields at Fossil Creek, Daylan Figgs is the Permittee/Operator contact, and no contact is given for the other two (weird!).
