On February 26, 2019 the Division of Reclamation, Mining and Safety (Division) <u>approved</u> the Technical Revision request (TR-5) submitted on February 4, 2019, addressing the following:

Revise reclamation plan-change seed mix, broadcast application, no mulching, tilling before and after seeding for the remaining 3.37 acres

The terms of the TR-5 approved by the Division are hereby incorporated into Permit No. M-1990-021. All other conditions and requirements of the permit remain in full force and effect.

The Division estimates the new reclamation liability to be less than the currently held Financial Warranty. Due to notice requirements a surety reduction cannot be done under a technical revision. If you would like to reduce your required bond amount please request a Surety Reduction (form enclosed).
