Dear Mr. Doody:

On March 15, 2019 the Division of Reclamation, Mining and Safety (Division) received your adequacy response for TR2). Based on the information received the Division determined that the following issue(s) of concern need to be adequately addressed before the Technical Revision can be considered for approval. Please provide the following:

- 1. Mining Map-Please specify the acres within each mining phase
- 2. Mining Map-Please indicate the affected land, i.e. the areas that will be mined vs those that won't be mined, any setbacks (Rule 6.4.3(d)).
- 3. Zoomed in Mining plan map-Please delineate the mining phases in addition to the permit boundary.
- 4. Zoomed in Mining plan map- is the 3.2 Acres of disturbance the total highlighted areas or just the area within phase one that has been disturbed?
- 5. Zoomed in Mining plan map-Please specify which stockpiles are topsoil and overburden to be used for reclamation purpose.
- 6. Reclamation Plan Maps- stockpiles, shaker and screen would be remove upon final reclamation therefore they should not be depicted in the map.
- 7. Reclamation Plan Maps-topography on reclamation map is the same as mining plan map, this indicates that little to no future mining will occur and that benches upon final reclamation will remain largely unchanged. The reclamation plan map should depict the anticipated future topography once mining has concluded.

Please submit your response(s) to the above listed issue(s) **by Monday, April 15, 2019** in order to allow the Division sufficient time for review. If you cannot address the above issues by April 15, 2019 please request an extension to the decision due date to ensure adequate time for the Division to review materials. A decision due date of April 30, 2018 has been set.
