Hi Ralph,

I completed a bond estimate for the 111c application submitted for the Hasser Borrow Pit (M-2019-015), and determined the required financial warranty to be in the amount of \$21,177.00 (see attached bond estimate).

Since you have already submitted \$12,500.00, the additional amount required is <u>\$8,677.00</u>.

Please contact Barbara Coria at 303-866-3567, ext. 8148 or at barbara.coria@state.co.us for questions regarding how to submit the additional bond.

The Act and Rules require an applicant to submit with a 111 application a minimum of \$2,500 per acre of affected land in the event the application is automatically issued as a result of Office inaction within 15 calendar days. Because you've already submitted this amount, \$12,500 (\$2,500 x 5 acres), I could go ahead and approve the application (and issue the permit after we receive the full amount) However, I wanted to give you some time to review my bond estimate first.

The application decision date is set for this Thursday, 4/25. I will be in the field tomorrow (Tues) and Thursday of this week. Therefore, I would need to approve your application today or Wednesday. Please review the bond estimate and get any comments to me no later than 3:00 pm on Wednesday. Otherwise, I will approve the application that afternoon with the bond set at the amount specified.
