Hi Jared,

Thank you for the revised bond. I think it's sufficient for what we've approved in the Ross's Plan of Operation, unless Scott Haas, the District Ranger, feels differently. In my last communication with Randy and Christine they noted that they had not been able to obtain permission to cross the small portion of private land that is between a decent road and their claim. I told them that if they were planning to go cross-country from a 4X4 road in order to access their claim we would need to amend their Plan to account for that. So far I have not heard back from them. I'm out of state this week for a class, but will reach out to them when I get back, and will keep you posted on any changes they may have. Due to the location of the claim and the amount of snow we got this year I don't see them operating before June at the earliest.
