AN AMENDMENT TO A REGULAR (112) CONSTRUCTION MATERIALS RECLAMATION PERMIT

PUBLIC NOTICE

Albert Frei and Sons, Inc. has filed an application amendment to a Reclamation Permit with the Colorado Mined Land Reclamation Board under the provisions of the Colorado Mined Land Reclamation Act for the extraction of construction materials. The proposed mine is known as the AFS-Bennett Pit, M-2001-038 and is located in Parts of the NE/4, SE/4, SW/4, NE/4, NE/4, and SE/4 of Section 2, T-3-S, R-63-W, 6th PM, Adams County, Colorado.

The proposed date of commencement was 2002 and the proposed date of completion December 2035. The proposed future use of the land will be rangeland.
