Hi Jason,

I appreciate you getting these coordinates and pics to me. I plotted them in Google Earth and found the marked permit area to be 109 acres, the western boundary is not quite straight, and the southern boundary sort of overlaps the topsoil pile (which is not good). To get the boundary marked correctly, it looks like you could move your NW corner marker due west 392 feet, and your SW corner marker 505 feet due south then 500 feet due west.

I'm attaching a Google Earth map showing the approved permit area compared to the permit area as delineated by the existing markers. The coordinates are on there too so you could use them as a guide when resetting your NW and SW markers.
