J-2 Contracting Company; 105 Coronado Court, Unit A-101, Fort Collins, CO 80525, 970-392-0694, has filed an application for a Regular (112) Construction Materials Operation Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed mine is known as the DPG Pit, and is located at or near Section 11, Township 5 North, Range 65 West of the 6th Prime Meridian.
