OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate the conditions observed.

The Colona Gravel Pit is located approximately eight miles south of Montrose and accessed from Hwy 550. The site is a 112c operation that includes a total of 73.9 permitted acres. The Division currently holds a financial warranty amount of \$165,351.00 for this site.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing that was clearly visible and adequate to delineate the affected area boundary.

The mining area consists of a north pit and a south pit. The north pit area is owned by the operator. The south pit area is owned by Uncompany Holdings, LLC. This inspection was focused in the south pit area.

The south pit area is in final reclamation. This inspection was conducted in order to observe and monitor conditions in the south pit area in order to address landowner concerns related to groundwater infiltration through the highwalls and exposed groundwater in the pit floor. There were no seeps in the highwalls observed during this inspection. There was no exposed groundwater observed in the pit floor during this inspection. The irrigation ditches on the west and east sides, adjacent to the pit were not flowing at the time of this inspection. The irrigation ditch on the west side of the pit, adjacent to Hwy 550, was flowing. The operator has constructed a ditch running along the base of the south and west highwall slopes in order to divert any seepage water around the south pit floor to the north pit area. No water was observed in the ditch.

Vegetation is becoming well established on the slopes and pit floor in the south pit area.

No problems or violations were noted during this inspection.
