OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The East Douglas Creek Gravel Pit is located approximately nineteen miles south of Rangely and accessed from CR27. The site is a 112c operation that includes a total of 15.29 permitted acres. Pursuant to C.R.S. 34-32.5-117 (3)(f)(VIII) a financial warranty is not required for this site.

A sign with the permit number was posted at the entrance to the site.

The affected area was marked by posts that were clearly visible and adequate to delineate the affected area boundary.

Mining was not occurring during this inspection. Stockpiles are located on the quarry floor east of the current mining area. Mining is progressing into the west slope of the permit area. The current highwall ranges from near vertical to 1H:1V slope. A sediment retention pond located near the west entrance appears maintained and effective.

Erosion or stability problems were not noted.

Noxious weed infestations were not observed.

No problems or violations were noted during this inspection.
