### **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Quinn Draw Gravel Pit is located approximately six miles northeast of Rangely and accessed from CR122. The site is a 110c operation that includes a total of 9.99 permitted acres. Pursuant to C.R.S. 34-32.5-110 (6) a financial warranty is not held for this site.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by fencing and posts that were clearly visible and adequate to delineate the affected area boundary.

Materials stockpiles were located throughout the pit floor. Topsoil stockpiles appeared stable. Slopes of the pit have been left at approximately 2-3H:1V.

Noxious weed infestations were not observed.

No problems or violations were noted during this inspection.
