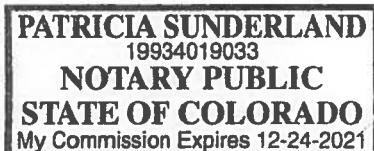

The proposed mine is known as the Best Rock Sand & Gravel Pit 1, and is located at or near Section 14, Township 15S, Range 96W, of the 6th Prime Meridian. The proposed date of commencement is August 2019, and the proposed date of completion is October 2069. The proposed future use of the land is general agriculture.
