OBSERVATIONS

This inspection was conducted as part of the normal monitoring program for permitted Designated Mining Operations established by the Colorado Division of Reclamation, Mining and Safety. The West Sunday mine is a 112d-3 operation that is currently in Temporary Cessation and consists of a maximum allowed disturbance of 20 acres. The status of Temporary Cessation went into effect April 19, 2015 and expires on April 19, 2020. Public access to the site is controlled by a locked gate along the access road. The Division currently holds \$85,036.00 in Financial Warranty for the site. A reclamation cost estimate update was not performed at this time. No Operator representative was present during the inspection however James Blair of the Bureau of Land Management was present. Four Photos accompany this report to illustrate the current conditions of the site.

As seen in Photo One, the permit ID sign was observed at the entrance to the site. The permit boundary markers were also observed. The remote vent shaft sites were not inspected at this time. Evidence that the diversion ditches and storm water control devices are functioning as designed was observed and no significant erosion was observed throughout the site.

All work and shop appeared to be in good condition as seen in Photos Two and Three. The shop and storage facility in Photo Two was discovered to be unsecure, with the bay door opened. According to the operator there appeared to be no signs of theft or damage to the structure. The office facility was secured, and no signs of attempted unauthorized entry were noted on that facility. The portal located on site has been opened to be used as ventilation for the underground workings of the entire Sunday Complex. The earthen backfill material has been removed but the gates remain locked to prevent unauthorized entry. The portal with its locked gates can be seen in Photo Four. Two fuel storage containers were observed on site but were empty and appear to have not been utilized in some time. Various other debris was observed on site however it was stored in an orderly fashion and was not a concern at this time. The main pad and work area was in good condition, evidence of weed management during the growing season was observed. The whole site exhibits positive drainage and no erosional issues were observed at this time. Some areas around the perimeter of the pad area have begun to revegetate themselves with volunteer species.

The overall footprint of the site was in good condition and free from excessive trash and debris. The condition of the site remains largely unchanged from the previous inspection. No problems or possible violations were noted at this time.
