Dear Mr. Robinson,

The Colorado Division of Reclamation, Mining and Safety (DRMS or Division) received your request for the Mined Land Reclamation Board (Board) to extend the corrective action deadline regarding violation number MV-2019-005. At your request the Division has scheduled this matter to be considered by the Board during the September 25 and 26, 2019 Board meeting. The DRMS staff does not oppose your request for additional time and has placed this item on the Board's consent agenda. Given this, an actual formal public hearing will not occur regarding this matter but the Board will take action and vote based on your request. You will not need to attend the meeting in person if you do not wish to do so.

This matter will be brought before the Board, following the hearing, all parties have an opportunity to review and comment on a draft of the Board's order before it becomes final. If you wish to do so, you must provide the Board with a written request to review the draft Order prior to or at the time of your hearing, or you must inform the Board orally during the hearing that you request to review the draft Order. You must include your mailing address and, if possible, an email address. You will be provided a copy of the draft Order for your review as soon as it is available. The Board must receive your comments on the draft Order within ten (10) calendar days of the date the draft Order is mailed, unless that deadline is extended. Please note that the Division of Reclamation, Mining and Safety has requested and will be allowed to review and comment on the draft Board Order prior to mailing to any party. The Board will resolve any issues regarding the form of the order. This process does not affect your right to request reconsideration by the Board or appeal the substance of the order.
