Notice to Interested Persons for Ducray Pit #2

Dear Party and/or Interested Person:

On September 11, 2019, the Division of Reclamation, Mining, and Safety (Division or Office) issued its decision to approve the application for the Ducray Pit #2, File No. M-2019-035, submitted by Martinez Western Construction, Inc.

This decision is based on the Division's determination that the application satisfies the minimum requirements of the Colorado Land Reclamation Act of for the Extraction of Construction Martials, §34-32.5-101 <u>et seq.</u>, C.R.S. (the Act) and the Minerals Rules and Regulations of the Colorado Mined Land Reclamation Board for the Extraction of Construction Martials (the Rules) for a reclamation only permit. The Office is mandated to approve an application that meets the minimum requirements under C.R.S 34-32.5-115(4). Please find enclosed the Division's rationale for its decision to approve, dated September 11, 2019.

Pursuant to Rule 1.4.6(2) of), the Division will not schedule the matter for consideration by the Mined Land Reclamation Board (MLRB). Pursuant to Rule 1.4.11(1), any person who can demonstrate the they are directly and adversely affected or aggrieved by the Division's decision, and whose interest are entitled to legal protection under the Act, may petition for a hearing before the MLRB. Such written petitions must provide the information specified under Rule 1.4.11(1)(d). Pursuant to Rule 1.4.11(1)(b), such petitions must be received by the Division within 30 days of the date of this notice, due October 11, 2019.
