



Lincoln County, 103 Third Ave Hugo, CO 80821, 719-743-2337, has filed an application for a Construction Materials Limited Impact (110) Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed pit is known as the Jamaco Pit, and is located at or near Section 33, Township 8s, Range 53w.

The mine is currently in production. The

proposed change is a boundary change that will not increase the size of the current operation. The proposed future use of the land is agricultural.

Subject: Temporary cover

Hi Ken,

Here are some annual crops and perennial crop that would be possibilities for temporary cover on spoil piles or stock piles as per your request:

Annual

Millet (foxtail variety or feed variety) seeding rate 4 lbs. /acre,

Planting date 5/ 15 -6/30

Wheat seeding rate 10 lbs. /acre, planting date 8/ 20 -9/ 30

Oats seeding rate 15 lbs. /acre, planting date 3/ 1 - 4/ 30

Perennial

Smooth brome seeding rate 13 lbs. /acre PLS, planting date 11/ 1 - 5/ 1

These seeding rates are based on that a drill will be used to plant the seed. I would probably recommend the millet as the first choice of annual cover then wheat or oats. Areas to be seeded should be as weed free as possible reducing competition for establishment of temporary cover.
