Dear Mr. West,

Brad Banulis, Terrestrial Biologist for Colorado Parks and Wildlife, and I met with John Kuijvenhoven, applicant for the Horsefly Rock Source mining operation (M2019-010) in regards to our previous letter dated September 8, 2019.

Mr. Kuijvenhoven said that within the application it states, "Mining, crushing, and screening may take place in any part of the year but is expected to be limited to less than 7 months per year" but that it should more accurately be worded "less than approximately 210 days per year". Mr. Kuijvenhoven asked if we would consider amending our recommendation so that a limited amount of work can be conducted on site during the winter months.

Again, we cannot express the importance of winter range habitat. Development and associated cumulative impacts for development are a huge threat to winter range habitat and wintering wildlife.

We recommend that if work has to take place from December 1-April 31 that the following conditions be met:

- No mining, crushing or screening take place
- Pick up and hauling from the pit is conducted only 2-3 days/month
- Hours of work at the pit are 10am 2pm
