The emergency response authority of the Division of Reclamation, Mining and Safety (the "Division") is set forth in Sections 34-32.5-121 and 34-32.5-124 of the Colorado Land Reclamation Act ("Act") and Rule 8.4 of the Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for the Extraction of Construction Materials ("Rules"). As outlined in Section 34-32.5-121 and Rule 8.4, this emergency response includes the authority to issue a Cease and Desist Order for an activity suspected of causing an emergency situation. The Division has determined the release of water from process ponds has created an emergency at the above-referenced operation that resulted in an immediate and undue risk of serious harm to persons, property, or the environment.

To allow the Division time to further inspect the site, evaluate the risk, and evaluate a reclamation plan, the Division orders Gillette Sand and Gravel, Inc., its associates, and its receiver to immediately cease and desist all mining, prospecting, milling, exploration, and other mining operations at the above-referenced site or at any off-site areas. Until this cease and desist is lifted by the Division, no one associated with Gillette Sand and Gravel, Inc., its associates, and its receiver is permitted to enter the site to conduct mining, prospecting, milling, exploration, and other mining operations. Any required remedial actions must be approved in writing by the Division prior to initiation.
