This list identifies the environmental and permit parameters inspected and gives a categorical evaluation of each. No problems or possible violations were noted during the inspection. The mine operation was found to be in full compliance with Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for the Extraction of Construction Materials and/or for Hard Rock, Metal and Designated Mining Operations. Any person engaged in any mining operation shall notify the office of any failure or imminent failure, as soon as reasonably practicable after such person has knowledge of such condition or of any impoundment, embankment, or slope that poses a reasonable potential for danger to any persons or property or to the environment; or any environmental protection facility designed to contain or control chemicals or waste which are acid or toxic-forming, as identified in the permit.

## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. David Wykoff and Kevin Hamatake, representing the Operator, were present. Photographs are included with this report in order to illustrate some of the conditions observed.

The mine is located approximately six miles east of Sargents in Saguache County and accessed from Marshall Pass Road. The site is a 112d operation that includes a total of 2,912 permitted acres. The Division currently holds a financial warranty amount of \$2,263,000 for this site. An updated reclamation plan for the site has been submitted to the Division. The application, AM-1, is currently under review.

Adequate mine identification signage was noted at the entrance to the site.

<u>Mill Site</u>: Final reclamation grading has been completed in the mill site area. The area has been seeded and vegetation is well established.










<u>Limestone Quarry</u>: The limestone quarry slopes appear stable. Reclamation has not occurred in this area yet. Slope reduction, topsoil replacement and revegetation will be required in this area for final reclamation.



<u>Roads</u>: No problems were noted with any of the internal roads. The roads are well maintained. The repair work completed in 2015 on the failed portion of the access road appears stable. The repair area has been seeded and vegetation is becoming well established.




<u>South Pit</u>: The phosphate injection program is ongoing in this area. No problems were noted with the drill pads, wells or associated equipment. The Division's June 2017 inspection report noted an area of slope failure in the upper part of the south pit. The failure area was not inspected during this inspection. Repair work has not yet taken place on the slope. The repair work is scheduled to commence in 2020. The failure poses no risk to public safety.
















North Pit: Slope movement above the North Pit continues to be monitored. No new evidence of significant movement was observed in the area of tension cracks above the pit. A final reclamation/stabilization plan has been developed for this area. The application, AM-1, is currently under review. Efforts are ongoing to control erosion and drainage on the east wall of the north pit.

Discharge from the North Pit Lake flows through the valve and culvert as designed. The Pinnacle Portal continues to discharge and flow is measured through a v-notch weir. The discharge reports to a marsh area above the facilities shop building.












Shop Area: No problems were noted in the shop area. The area is well maintained.





<u>Indian Rock Dump</u>: Slopes appear stable and vegetation is becoming well established on the reclaimed slopes. No significant erosional features were noted. The phosphate injection program is ongoing in this area. Test cells are located on the bench above the rock dump. No problems were noted in this area.









<u>Sediment Pond</u>: The sediment pond appears functional and the pond slopes appear stable. Surface filter booms placed at the upper and lower ends of the pond are maintained and appear in good working order. No seepage or stability concerns were noted around the dam. The spill way channel appears to be maintained and in good working order. The treatment building at the base of the dam is scheduled for removal in 2020.







<u>Sandstone Quarry</u>: The sandstone quarry area is in final reclamation. The area has been regraded and reseeded. Vegetation is well established over most of the area. There is a small portion of the slope at the northeast end of the quarry that will require some "touch up" grading, topsoil replacement and reseeding in order to establish a vegetative cover.





No problems or violations were noted during this inspection.
