Notice to Interested Persons for Horsefly Rock Source

Re: Horsefly Rock Source, File No. M-2019-010, Construction Material (110) Limited Impact Permit Application, Decision to Approve Application with Objections

Dear Party and/or Interested Person:

On October 22, 2019, the Division of Reclamation, Mining, and Safety (Division) issued its decision to approve the application for the Horsefly Rock Source, File No. M-2019-010, submitted by John Kuijvenhoven.

This decision is based on the Division's determination that the application satisfies the minimum requirements of the Colorado Land Reclamation Act of for the Extraction of Construction Materials, §34-32.5-101 <u>et seq.</u>, C.R.S. (the Act) and the Minerals Rules and Regulations of the Colorado Mined Land Reclamation Board for the Extraction of Construction Martials (the Rules) for a reclamation permit. The Office is mandated to approve an application that meets the minimum requirements under C.R.S 34-32.5-115(4). Please find enclosed the Division's rationale for its decision to approve, dated October 22, 2019.

Pursuant to Rule 1.4.6(2) of), the Division will not schedule the matter for consideration by the Mined Land Reclamation Board (MLRB). Pursuant to Rule 1.4.11(1), any person who can demonstrate the they are directly and adversely affected or aggrieved by the Division's decision, and whose interest are entitled to legal protection under the Act, may petition for a hearing before the MLRB. Such written petitions must provide the information specified under Rule 1.4.11(1)(d). Pursuant to Rule 1.4.11(1)(b), such petitions must be received by the Division within 30 days of the date of this notice, due November 21, 2019.
