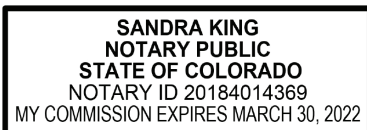

Castle Aggregate, 7250 Allegheny Drive, Colorado Springs, CO 80919, (719-598-0215), has filed an application for an amendment to their Regular (112) Reclamation Operation Permit with the Colorado Mined Land Reclamation Board under the provisions of the Colorado Mined Land Reclamation Act for the Extraction of Construction Materials. The mine is known as the Pikeview Quarry (M-1977-211) and is located in Section 9, Township 13 South, Range 67 West, 6th Prime Meridian.
