Dear Patrick,

I spent some time this morning going thur the file for the state pit (m1990-112) I review all of the available annual reports for the pit going back the original years it does appear that a few are missing.

It also appears that the reports were changed over the years a little confusing.

This is what I came up with and would like your confirmation of my numbers.

The total permitted land was - 1046 acres

The total permitted mining area was - 755 acres

The last reported affected land in the 2019 annual report from Fremont Paving was - 420 acres

By my calculations of reclaimed land over all the years of annual reports is - 302 acres

By my calculations, the state pit as of now should have a remaining, 33 acres left to mine.

Could you confirm these calculation, I started to question the numbers because every year they seamed to be reporting very similar numbers.

Is there a method to do a physical on site calculation. Between the changing annual reporting documents and the succession of operators over the years, it appears that the numbers seem to be misleading or off.

If need be I am asking or requesting at this time. That a current and accurate accounting of the total number of acres used, total numbers of acres reclaimed and the total number of acres that remain for mining be calculated.
