Correspondence with Seifert Construction

I spoke with Shawn Wise today regarding the 06/13/2017 CDRMS 112c Annual Report. Question 4 within the report had recorded that the Seifert Pit had last removed material 3/2016. The pit currently holds an intermittent operational status with CDRMS and the case is still active with BLM, however the most recent contract issued by BLM expired 8/30/2005. Therefore, Seifert Construction should not be removing any material from the pit till a new contract has been issued by BLM. The case is still active because reclamation requirements have not been met.

Shawn Wise looked through the Seifert Pit records and determined the production documented in the above CDRMS report was inaccurately recorded. I gave her Tim Cazier's (CDRMS, Custer Co) contact information to correct the production report. Ms. Wise clarified that Seifert Pit had not been active since the last contract in 2005. The last BLM inspection, conducted on 05/18/18 observed no evidence of recent or active operations. I told Ms. Wise to contact Mr. Cazier at the CDRMS office in order to correct the report and update all records.
