

Public Notice

Weldon Construction, LLC; PO Box 1170, Vernal, UT 84078; (435) 828-3329, has filed an application for a Regular (112) Construction Materials Operation Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed mine is known as the North River Gravel Pit, and is located at or near Section 5, Township 1, Range 102, 6th Prime Meridian.

The proposed date of commencement is January 15, 2020, and the proposed date of completion is December 31, 2030. The proposed future use of the land is rangeland.
