PUBLIC NOTICE

Elk Ridge Mining and Reclamation, LLC, P.O. Box 628, Nucla, CO 81424 has filed with the Division of Reclamation, Mining and Safety an application for Technical Revision No. 93 (TR-93) to the New Horizon Mine Permit No. C-1981-008. TR-93 proposes to modify Pond 009 to facilitate construction of stock pond SP2 on Elk Ridge Mining & Reclamation property.

The New Horizon Mine office is located at 27646 West 5th Street, P.O. Box 628, Nucla, Colorado. The permit area contains tracts of land located in Section 6, Township 46 North, Range 15 West; Section 31, Township 47 North, Range 15 West; Section 1, Township 46 North, Range 16 West; Section 36, Township 47 North, Range 16 West, of the New Mexico Principal Meridian, Montrose County, Colorado being more particularly described as follows:

A portion of the South 1/4 of Section 6, Township 46 North, Range 15 West, containing 27.01 acres; a portion of the South 1/4 of Section 6, Township 46 North, Range 15 West, containing 1.23 acres; a portion of the North 1/4 of Section 6, Township 46 North, Range 15 West, containing 8.88 acres; a portion of the Northwest 1/4 of Section 6, Township 46 North, Range 15 West, containing 11.79 acres; a portion of the Southwest 1/4 of Section 31, Township 47 North, Range 15 West, containing 119.43 acres; a portion of the South 1/4 of Section 36, Township 47 North, Range 16 West, containing 253.30 acres; a portion of the North 1/4 of Section 1, Township 46 North, Range 16 West, containing 114.01 acres; a portion of the Southwest 1/4 of Section 25, Township 47 North, Range 16 West, containing 98.62 acres. In total, the New Horizon permit boundary contains 634.27 acres, more or less. The above mentioned tracts of land are shown on USGS 7.5 minute Nucla Quadrangle map.
