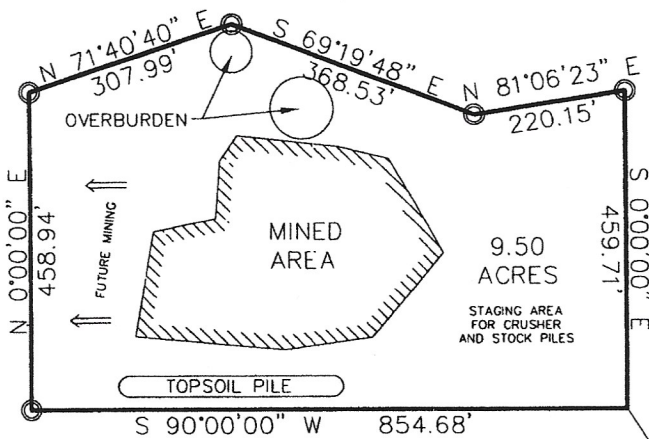
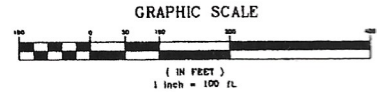

## DESCRIPTION

A TRACT OF LAND LOCATED IN PART OF THE E1/2 OF SECTION 6, TOWNSHIP 32 SOUTH, RANGE 63 WEST OF THE 6TH P.M., COUNTY OF LAS ANIMAS, STATE OF COLORADO, MORE PARTICULARLY DESCRIBED AS FOLLOWS:  
BEGINNING AT A POINT FROM WHICH THE SOUTHEAST CORNER OF SECTION 6 BEARS S 22°44'41" E, 2536.75 FEET; THENCE S 90°00'00" W, 854.68 FEET TO A POINT; THENCE N 00°00'00" E, 458.94 FEET TO A POINT; THENCE N 71°40'40" E, 307.99 FEET TO A POINT; THENCE S 69°19'48" E, 368.53 FEET TO A POINT; THENCE N 81°06'23" E, 220.15 FEET TO A POINT; THENCE S 00°00'00" E, 459.71 FEET TO THE POINT OF BEGINNING, CONTAINING 9.50 ACRES.

**BASE OF BEARING**  
THE BEARING OF N 88°50'55" W ON THE SOUTH LINE OF SECTION 6 (MONUMENTS DESCRIBED ON PLAT) WAS OBTAINED FROM G.P.S. OBSERVATION USING N.G.S. CONTROL STATION "IRONDAVO II" (A STAINLESS STEEL ROD SET FLUSH WITH THE GROUND) AND PUBLISHED NAD83(1992) DATA. ALL BEARINGS ARE RELATIVE THEREOF.
