NOTICE OF PROPOSED DECISION

The Colorado Division of Reclama-tion, Mining and Safety proposes to approve Permit Revision Application No. 1, submitted by Oxbow Mining, LLC for a coal mining permit at the Terror Creek Loadout (Permit No. C-1983-059). PR-1 proposes to change the postmining land use of the Terror Greek Loadout from irrigated hay cropland to industrial/commercial (initially as an RV/boat storage facility). The proposed changes in-clude a change to the post-mining topography. The Terror Creek Loadout is a/an loadout operation located in Delta County, approximately 4 miles Northeast of Paonia, Colorado. Coal interest is private, and the surface to be affected is private land. The permit area encompasses approximately 20.00 acres. This proposed decision is based on a finding that the proposed operation will comply with all requirements of the Colorado Surface Coal Mining Reclamation Act, Section 3433101, et seq., C.R.S., and the regulations promul-gated thereunder. Copies of the proposed decision, in-cluding any stipulations, are on file for public inspection at the Colorade Division of Replamation. Persons with an interest that may be adversely affected by the accessed deviation multiple by the proposed decision may request a formal hearing before the Mined Land Reclamation Board on the proposed decision. Such request must be made within thirty (30) days of the initial publication of this notice, must be in writing, and must state with reasonable specificity the reasons for the request and the objections to the proposed decision.
