On January 9, 2020, the Division of Reclamation, Mining and Safety received your 111 Materials Reclamation Materials Reclamation Permit Application package for the Horse Creek Pit, File No. M-2020-002. Preliminary review of the information received determined that the additional information must be received before the Division can consider your application as being submitted and technical review can begin.

Application:

1. Page 6 of the application is missing a corporate seal, please revise page 6 and resubmit with a fully executed page with a corporate seal. If you do not have a corporate seal please write "No Seal" in the space provided.

Rule 6.2.1 General Requirements of Exhibits

2. Rule 6.2.1 2(b) requires all maps to be "prepared and signed by a registered land surveyor, professional engineer, or other qualified person". Please resubmit maps with a signature.

Rule 6.3.7 Source of legal Right-to-Enter

3. Exhibit G requires documentation of a legal right to enter. While a lease from the State of Colorado was submitted with the application, the document was not signed by the Lessor. Please resubmit a fully executed lease agreement that has been signed by both the Lessor and Lessee.

Rule 6.3.11 Terms of government contract



4. Exhibit K requires evidence of the Performance and Financial Warranties under the government contract. Please submit evidence of both.

Rule 6.3.12 Permanent Man-Made Structures

5. Exhibit R requires a notarized agreement between the applicant and the person(s) having an interest in the structure, that the applicant is to provide compensation for any damage to the structure; or where such an agreement cannot be reached, the applicant shall provide an appropriate engineering evaluation that demonstrates that such structure shall not be damaged by activities occurring at the mining operation. Please provide evidence an attempt was made to obtain structure damage agreements and if an agreement cannot be reached, provide an appropriate engineering evaluation.

Your application will not be considered submitted until all the information listed above is received and found sufficient to begin our review.

You have sixty (60) days from the above date to submit all necessary documents that the Office needs for an application to be considered filed. If, at the end of the sixty day period, the application has not been determined to be filed with the Office, the Office will deny the application and terminate the application file.

This letter shall not be construed to mean that there are no other technical deficiencies in your application. The Division will review your application to determine whether it is adequate to meet the requirements of the Act after submittal of all required items.
