## **OBSERVATIONS**

This was a routine monitoring inspection conducted at the Lopez Quarry No. 2 by DRMS representative DJ Cunningham, Jared Ebert, and Rob Zuber. Lonnie Lopez represented S & S Services during the inspection. This site is an active, 9.80 acre, 110c permit held by S & S Services. Approximately 4 acres of the permitted area has been disturbed to date with the remainder of the site undisturbed.

The site identification sign was posted at the mine site boundary markers were noted throughout the permitted area. No mining activity was going on at the time of the inspection. A 15 foot high wall with a slope of 0.5:1 angle was noted in the middle of the active area during inspection. Efforts to reclaim portions of the land had been noted in the southern section of the permitted area with section having been backfilled and graded to a 5:1 slope and vegetation being established in the south eastern areas.

An aerial photo of the site area has been included to depict the general condition of the site at this time. All activity appeared to be in compliance with the approved mining plan, and no other issues requiring corrective action were observed during this inspection.

The Division currently holds a cash bond in the amount of \$22,685.00. Based on the observations made during this inspection, the Division estimates the reclamation liability at the site to be \$24,832.00. Enclosed is a copy of the Division's reclamation cost estimate. The Division requests that the Operator review the enclosed cost estimate and forward any questions or concerns to me by **February 10, 2020**. The Division may issue a new surety increase after **February 10, 2020**. If so, the Operator will have sixty days from the date of the surety increase notice to submit the required surety increase in accordance with Rule 4.2.1(2).
