OBSERVATIONS

This was a routine monitoring inspection conducted at the North River Pit by DRMS representative DJ Cunningham. Jodi Schreiber and Herb Pearson represented All-Rite Paving & Redi-Mix, Inc(Operator). during the inspection. This site is an active, 275.45 acre, 112c permit held by All-Rite Paving & Redi-Mix, Inc. Approximately, 35 acres of the permit area has been disturbed to date with the remainder of the site undisturbed. The site was not active at the time of the inspection.

The site identification sign was posted at the mine site entrance and the permit boundary was marked. Slopes were mined at a 3H: 1V or greater slope. Topsoil was being stored on the site in berms around the perimeter of the lake. The topsoil stockpiles were stable with vegetative cover. According to the Operator, material is being brought in from other mine sites and being washed at the North River Pit.

The south side of the mine was not observed during this inspection due to inability to access the area. After observing previous images of the site on Google Earth, it appears that there has not been any mining activity in the area for quite some time. The Division estimates 19 acres have been disturbed in the south area. It is the recommendation of the Division that the south area of the mine begin final reclamation. If the Operator intends to mine the south area in the future, the Division recommends the Operator keep the south area stable, free of erosion, and weeds.

During the inspection, a storage area (Photo:) was noted in the western portion of the permit area. The storage area was noted to be right up to the permit boundary. It is recommended by the division that the Operator monitor this area and ensure that they do not operator outside their permitted area

Significant state-listed noxious weed species, tamarisk (salt cedar), were observed along the river that cuts through the permitted area. The Division received a technical revision on January 5, 2020 to add a weed plan to address the tamarisk in the permitted area.

The Division holds a financial warranty in the amount of \$431,039.00 in the form of a corporate surety. The Division finds the financial warranty amount adequate at the time.
