OBSERVATIONS

This was a normal monitoring inspection of the Pig Mesa Pit; DRMS file# M-1978-168. This site is located about 4.5 miles north east of Delta, Colorado in Delta County. I, Stephanie Mitchell of the Colorado Division of Reclamation Mining and Safety conducted the inspection. Mr. Larry Record of Delta County accompanied me on the inspection.

This site is permitted for 331.60 acres with about 29.7 acres currently disturbed. The Division does not hold a financial warranty for the site, for it is a government entity.

Adequate mine identification signage was noted at the entrance off of Fairvierw Road and is in accordance with Rule 3.1.12(1).

The permit area is delineated by boundary marker posts. Material stockpiles and topsoil/overburden stockpiles appear to be stable. Mining is currently taking place in the Northeast corner of the permit area. The highwall is 25-30 feet high. A loader was the only equipment on site. No fuel is being stored at the mine site.

There were little or no weeds on site.

Overall, no problems were noted on this site. The operation appears to be in compliance with the approved mining plan.
