No. 7 (RN-7), submitted by Oxbow Mining, LLC for a coal mining permit at the Elk Creek Mine (Permit No. C-1981-022). The proposed renewal will allow for continued mining and/or reclamation operations at the site.

The Elk Creek Mine is a/an underground operation located in Delta, Gunnison County, approximately 0 miles North of Somerset, Colorado. Coal interest is federal and private, and the surface to be affected is federal and private land. The permit area encompasses approximately 15,676.51 acres.

This proposed decision is based on a finding that the proposed operation will comply with all requirements of the Colorado Surface Coal Mining Reclamation Act, Section 3433101 et seq., C.R.S., and the regulations promulgated thereunder.
