Eastern Colorado Aggregates, LLLP (ECA), is requesting an extension to the erosion control corrective action due date requested on January 9 and approved.

On January 21, 2020, ECA had rip-rap delivered to the site and equipment mobilized to begin stabilizing the problem areas and make appropriate repairs to the bank and road on the east side of the lake. The February weather proved to be problematic in completing the stabilization. ECA needs to have more rip-rap delivered to correct the erosion problems in a few more spots. The plan is to finish the stabilization work during the first week of March. ECA requests an extension to complete the erosion stabilization work no later than March 31, 2020. ECA will provide photos of the stabilization once it has been completed.

ECA is still on target to meet the noxious weed corrective actions by August 31, 2020, although ECA has had problems connecting with the Midwestern Farms owners about the reseeding. ECA will continue to reach out to Midwestern Farms to get this issue resolved.
