On February 28, 2020, the Division of Reclamation, Mining and Safety received the Application Form for Transfer of Mineral Permit and Succession of Operators from Colorado Moss Rock, Inc. to Premier Moss Rock, LLC for the Colorado Moss Rock site, Permit M-2011-039. The following items are incomplete for the application to be processed:

1. On page 5, the company name for the prospective successor operator needs to match what is on file with the Colorado Secretary of State exactly. Please update the company name there is a missing comma.
2. On page 6, Designation of Review Timeline, initials of the permittee and prospective permittee need to be on the same sheet of paper.
3. On page 8, the permit number is incorrect, M2011-139 needs to be corrected to M2011-039.
4. On page 8, the permit (M2011-039) was granted to Colorado Moss Rock, Inc. not Kim Barickman, dba Colorado Moss Rock, Inc., please update with the correct permittee name.
5. On page 8, the company name for the prospective successor operator needs to match what is on file with the Colorado Secretary of State exactly. Please update the company name there is a missing comma.



6. On page 9, the permit (M2011-039) was granted to Colorado Moss Rock, Inc. not Kim Barickman, dba Colorado Moss Rock, Inc., please update with the correct permittee name.
7. On page 9, the company name for the prospective successor operator needs to match what is on file with the Colorado Secretary of State exactly. Please update the company name there is a missing comma.
8. On pages 9 and 10, please insure that in the notary section the name of companies, both current and prospective operators, matches what is on file with the Colorado Secretary of State exactly.
9. Structure Agreement Form, please provide a list of the structures that are located within 200 feet of the affected area.
10. Structure Agreement Form, certification page, the company name needs to match what is on file with the Colorado Secretary of State exactly. Please update the company name there is a missing comma.
11. Financial Warranty, page 1, the permit number is incorrect, M2011-139 needs to be corrected to M2011-039.
12. Financial Warranty, page 4, the company name needs to match what is on file with the Colorado Secretary of State exactly, please update.
13. Financial Warranty, page 4, notary section, the name of the needs to match what is on file with the Colorado Secretary of State exactly.
14. Performance Warranty, page 1, the permit number is incorrect, M2011-139 needs to be corrected to M2011-039.
15. Performance Warranty, page 1, the company name needs to match what is on file with the Colorado Secretary of State exactly, please update.
16. Performance Warranty, notary section, the name of the needs to match what is on file with the Colorado Secretary of State exactly.

Please provide the above documents by April 28, 2020. All completed permit documents are required to be submitted for consideration of your Request for Transfer of Mineral Permit and Succession of Operators Application. An incomplete application will be denied after the 60 day submittal request, if requested documents or information are not received. Forms available at <https://www.colorado.gov/drms>
