Two Rivers – Permit M-1998-038**

Dear Mr. Lennberg:

Kirkland Construction, RLLP (Kirkland), is requesting an extension to three of the four the corrective action due dates for the items listed your Two Rivers inspection report dated January 17, 2020.

1. Cited problem #1 - The current landowners, Kurt Blackburn and Jeff Patch, have given Kirkland legal right of access, as stated in the attached letter dated February 18, 2020.
2. Cited problem #2 - If Kirkland would like to modify the approved reclamation plan, Kirkland will submit a Technical Revision to the DRMS to update and clarify the current approved reclamation plan to reflect the existing and proposed activities. Kirkland is requesting a corrective action date of April 30, 2020.
3. Cited problem #3 – Kirkland will provide proof the boundary markers have been surveyed and correctly marked. Kirkland is requesting a corrective action date of April 30, 2020.
4. Cited problem #4 – Kirkland will implement the approved weed control plan to reduce the spread of the noxious weeds and provide evidence to the DRMS. Kirkland is requesting a corrective action date of August 31, 2020 to allow remediation during the growing season.

Kirkland will also correct the deep excavation immediately adjacent to the highwall in the southeastern corner and correct the erosion rills on the southern border of the excavation.


