Hi, Peter.

My name is Marit Fischer. I am the daughter of Martha Malone (Jeanell) and the personal representative of her estate, *The Estate of Martha Jeanell Malone*. She passed away in May 2016.

In 2018, my brother and I sold the Tigris claim and adjacent BLM parcels to Mr. Paul E. Danio (PO Box 1074, Central City, CO 80427, phone: 720-503-7294). As neither my brother nor I were interested in the claim, nor in setting up probate in the state of Colorado to deal with it, we were pleasantly surprised when Mr. Danio contacted me out of the blue to purchase the property. He assured me at that time that with our submission to him of a notarized quitclaim deed (the unsigned digital copy of this document is attached for your reference), he would handle the transfer of the deed to his name. We completed our part of the deal on May 23, 2018, and he paid us \$6,000. To us, it was a done deal.

Mr. Danio, however, in the two years since, has failed to transfer the deed to his name. The property has subsequently gone up for auction due to non-payment of back-taxes. I notified Mr. Danio of this a year ago after I received a post card from Clear County, at which time he told me again that he would handle the transfer. He has not done so.

I am not opposed to the sale of the property at auction. My interest in it has expired.

I briefly visited the property only one time, in 1996. I am not familiar with what is happening there now nor with what has transpired there over the past 26 years, let alone over the course of its entire history. Until I received your letter, I was unaware of any current mining activity there or near there (staged or otherwise) nor of the Discovery Channel show. I am also unfamiliar with any of the sites and claims near the property that she once owned.

I am sorry that I cannot help you, but I wish you the best in getting to the bottom of the challenge before you. I hope that those who are responsible decide to cooperate and work within the laws of the state and the expectations of your department.
