OBSERVATIONS

The Henderson Mill was scheduled to be inspected by Peter Hays, D.J. Cunningham and Amy Eschberger with the Division of Reclamation, Mining and Safety (Division/DRMS) as part of the Division's monitoring inspection program on April 7, 2020. However, due to the COVID-19 pandemic, Governor Polis issued an executive order with travel restrictions for state employees. Therefore, the Division is unable to perform the inspection at this time.

The Division was prepared to inspect the storm water control structures at the Mill facility and tour the Mill building for the purpose of familiarizing the new DRMS staff member with the Henderson Mill operation. The storm water inspection and the facilities tour at the Mill will be rescheduled once the travel ban is lifted by the Governor.

The Operator provided As-Built Drawings and Engineering Certification for Phase 1 of the 3-Dam Buttress Project on March 20, 2020. The Division sent an adequacy letter to Henderson on March 25, 2020. The Operator informed the Division by email a response to the Division's adequacy items would be provided soon.

TR-31

The Operator provided As-Built Drawings and Engineering Certification for the Additional 3-Dam Seepwater Return Line Cleanout Ports on March 20, 2020. The Division sent an adequacy letter to Henderson on March 27, 2020. The Operator informed the Division by email a response to the Division's adequacy items would be provided soon.

3-Dam Buttress Project - Phase 2

The Operator informed the Division by email the design for Phase 2 of the 3-Dam Buttress Project would be submitted for the Division's review in a few weeks. The construction of Phase 2 is scheduled for this summer.
