### ENTRY OF APPEARANCE AND MOTION TO CONTINUE VIRTUAL HEARING SCHEDLUED FOR APRIL 22, 2020

ENTRY OF APPEARANCE: Aldrich Law Firm, LLC, by Frederick G. Aldrich, Esq., enters its appearance on behalf of Pinion Ridge Mining, LLC.

MOTION TO CONTINUE HEARING: Pinion Ridge Mining, LLC ("PRM"), by the undersigned counsel, requests that the Mined Land Reclamation Board's ("Board") virtual hearing in the above matter now scheduled for April 22, 2020 be continued from April 22, 2020 until after the Colorado Department of Health and the Environment (CDPHE), Public Health Order No. 20-24 (the "Stay at Home Order") expires on April 26, 2020 or, if the Stay at Home Order is extended, until the Stay at Home Order is lifted.

As grounds, PRM states:

- 1. The CDPHE has issued four updates to its Stay at Home Order because of the Covid-19 pandemic. The current Stay at Home Order expires April 26, 2020. The Stay at Home Order means persons are to stay at home except for necessary activities, minimum basic operations, critical government functions and critical businesses.
- 2. The President of PRM is George Glasier. Mr. Glasier lives outside of Nucla, Colorado in the west end of Montrose County. He is observing the Stay at Home Order.
- 3. Although Mr. Glasier has Internet service to his residence, the Internet service is unreliable, intermittent and slow. He cannot connect with Zoom or effectively participate in a virtual hearing through the Internet. For Mr. Glasier to participate, he would be required to attend the hearing at a location that violates the Stay at Home Order.
- 4. As the President of PRM, Mr. Glasier oversees all phases of PRM's mining activities and has knowledge of its mining activities relevant to the issues regarding cessation and resumption of mining activities for the Sunday mine complex.

- 5. Mr. Glasier's full participation at the hearing is critical to the interests of PRM. PRM would be prejudiced by Mr. Glasier's inability to attend in person.
- 6. This matter has been continued twice from March 25-26, 2020 to April 22-23, 2020 and from April 22-23, 2020 to May 13-14, 2020. It was re-scheduled back to April 22, 2020 as a virtual hearing by email dated April 10, 2020.
- 7. PRM submits that neither the Board nor the parties seeking intervention will be adversely affected by this request for continuance considering the Stay at Home Order and the extraordinary circumstances of the Covid-19 pandemic.

### **RELIED REQUESTED:**

PRM asks the Board to vacate the virtual hearing scheduled for April 22, 2020 until the Stay at Home Order expires on April 26, 2020 or, if extended, until the Stay at Home is lifted.
