Box 722410 Norman, Oklahoma 73070, (405-990-3148)), has filed an application for a Construction Materials Limited Impact (110) Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed mine is known as the Saddlebrooke Pit, and is located at or near Section 24, Township 39.0, Range 2.0.

The proposed date of commencement is May 15th, 2020, and the proposed date of completion is May 15th, 2030. The proposed future use of land is rangeland.
