Dear Mr. Lennberg,

In accordance with Rule 9, Section 3.1.7 of the Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for Hard Rock, Metal, and Designated Mining Operations (Rules), the Cripple Creek and Victor Gold Mining Company (CC&V) hereby provide the Division of Reclamation, Mining, and Safety (Division) with a formal notification of water quality parameter exceedances.

CC&V collected second quarter compliance groundwater samples from monitoring wells CRMW-5B, CRMW-5C, and SGMW-6B on April 8, 2020. CC&V received the lab report for these analyses on April 17, 2020, and upon review, CC&V determined that CRMW-5B, and CRMW-5C exceeded established numeric protection limits for fluoride, and SGMW-6B exceeded established numeric protection limits for fluoride, manganese, and sulfate. The table below lists the exceedance for the location and the associated parameter and the attached graph demonstrates the parameter trend for collected data from Q1 2017 to present.
